Handicap Singles Snooker Tournament

WHEN	: To be held on Saturday 8th & Sunday 9th August 2026.
WHERE	: Mingara Recreation Club, Mingara Drive, Tumbi Umbi NSW
STARTING TIME	: Games commence 9.00 a.m. SHARP on both Saturday & Sunday
ENTRY FEE	: \$45.00 per player (Max 46 Runners)
ENTRIES CLOSE	: Nominations (& entry fees) must be received by 7pm Mon 3 rd August 2026

Conditions of Entry

1. Tournament is conducted under the Rules of Play & Code of Ethics as contained in the Australian Billiards & Snooker Council Handbook (and amendments).
2. Nomination is by way of signed entry form and payment of entry fee. All entries will be subject to acceptance by the Tournament Committee. No entry fees will be refunded after draw has been completed.
3. Tournament will be a singles format with individual handicaps allocated for all players.
4. The Draw will be released without handicaps on the 6th August via the Mingara Snooker & Billiards Facebook page. <https://www.facebook.com/MingaraSnooker>. All handicaps will be allocated at the Tournament Committee's discretion and may be altered up to and including the 2nd round. Handicaps will be released on the day of play.
5. Dress code will be enforced. Saturday: Neat & tidy casual dress standards will apply, with a minimum of long trousers, collared shirt/blouse (this can be your club Shirt) but must have a collar), socks and enclosed dress shoes. Strictly no shorts, thongs, sandals, runners etc. Sunday: Tournament dress standard is required - long sleeve shirt buttoned at wrist, waistcoat, dress trousers, dress shoes, tie is optional. Failure to comply with this condition will result in forfeiture.
6. A Roaming Referee Saturday and Sunday. Semi Final and Final a referee will be provided.
7. NOTE: a restricted version of the "Foul & A Miss" Rule will be enforced for this Tournament as follows - a maximum of two (2) attempts only at escaping a snooker situation will apply. This is subject to the player concerned making a valid attempt, i.e. cue ball must be struck with sufficient force to reach the object ball, etc. Players are requested to use common sense in all instances during this Tournament or ensure roaming Referee is available..
8. Preliminary rounds and Quarter-finals will be best of 3 frames; Semi-finals and Final best of 5 frames.
9. All players not qualifying for the quarter-finals will be eligible to enter a repechage on Sunday (2 frame continuous). Same dress code for Saturday will apply to these players.
10. Any player not present after 10 mins of being called to the table will lose a frame. Should a player be another 10 minutes late then he/she will forfeit the match.

11. Junior players will be accepted, subject to normal Mingara Recreation Club rules and regulations being observed.

12. Tournament Committee decisions will be final in all instances.

INDEMNITY: All participants enter at their own risk. Neither the club, nor sponsors, nor organisers shall be liable for any loss, injury or misadventure however arising.
